Downunder Daily Heavy Metal

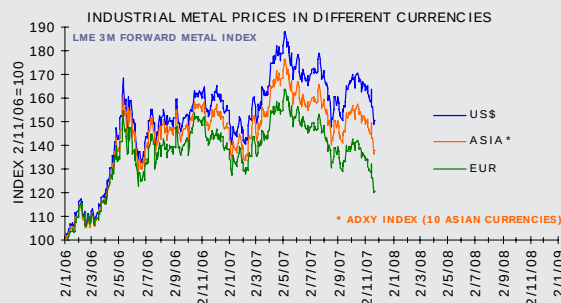
The decline in metal market is becoming more serious. The LME's base metal index is now down 20% from its May peak. That's in US\$ terms; in terms of other (stronger) currencies, the decline is even more pronounced, and in euro terms the index is now at an 18-month low (Exhibit 1).

Of course, metal prices – like other industrial commodity prices – remain at historically elevated levels (Exhibit 2). A 30%-type fall in metal prices (something I expect next year), would still leave prices around 50% above prior cycle peaks. Put another way, it would be possible to see a big price fall and still believe that the commodity super-cycle is intact.

How likely is such a fall? The first point to acknowledge is that there is now a high level of financial/speculative participation in metals markets. That may mean that prices do not provide as 'clean' a read on underlying activity levels as has been the case historically. Financial participants may have pushed prices beyond what was justified by supply-demand fundamentals. Those speculative flows also mean that commodity prices may now be more correlated with other financial measures of risk appetite than has been the case historically, suggesting that the current setback may reflect the travails in financial markets.

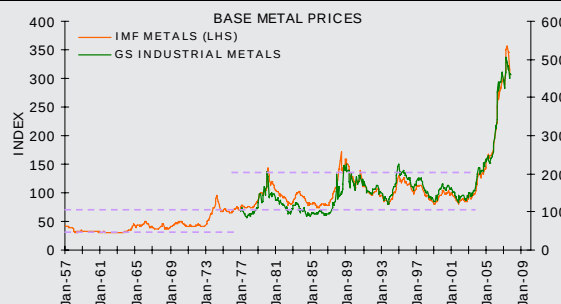
My view, however, is that metal markets remain, over the medium term, predominantly creatures of the economic cycle. Exhibit 3 shows that the ebb and flow of global industrial production growth still explains much of the variation in metal prices through this cycle. On that basis, the softening in prices may be a warning that growth is cooling.

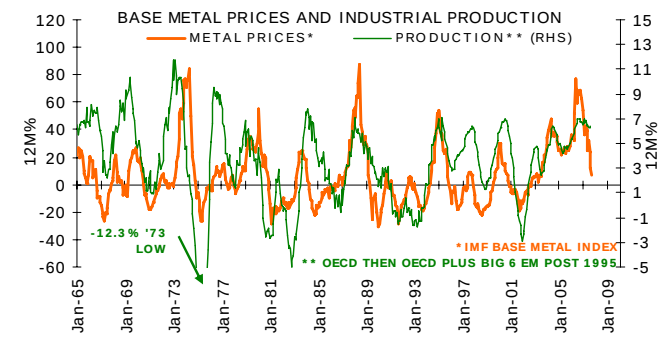

It may also be that the long-awaited supply-side response is now affecting some prices. As I've noted before, it's remarkable that metal prices have been in a broad sideways range through the past 18 months, notwithstanding the cracking pace of global growth. Either the US residential downturn has capped prices, or supply is starting to respond.

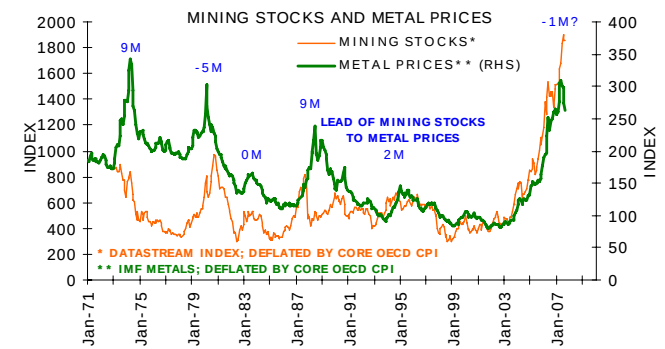
Exhibit 3

Regardless of what has capped prices so far, the bigger-picture point is that the growth risks seem heavily slanted to the downside next year. Even if Asia keeps growing, there are question marks over growth in the US, Europe, the UK, and Japan. That, in my view, means that metal prices can fall even if Asia maintains current growth.

Who's Leading Whom?

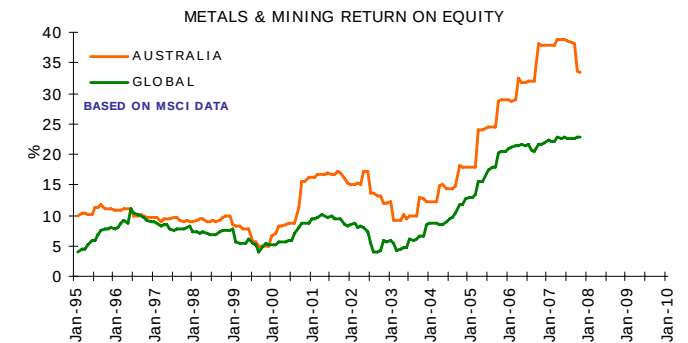

Consensus forecasts embody a degree of commodity price decline in coming years. However, historically, mining stocks and spot commodity prices have been highly correlated. To be fair, stock prices often (but not always) lead spot prices, particularly at turning points. Exhibit 4 highlights the gap (in months) between the peak in stock

prices and the peak in spot commodity prices. To 'validate' the fall in spot commodity prices, you would expect stock prices to fall fairly soon.

Looking farther out, there are signs that returns (on an ROE basis) have likewise peaked (Exhibit 5). Returns may stay above historical levels for an extended period, given the slow supply response through this cycle. But the process of mean-reversion may now be under way, and would almost certainly be accelerated by a global slowdown in 2008.
